RESOLUTION NO. SP-**2198**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE COMPANY FOR THE CONSTRUCTION OF STREETLIGHTINGS AND DEEP WELLS AT SUCH AMOUNT OF TWO MILLION FIVE HUNDRED THOUSAND PESOS (P2,500,000.00) AS COST ESTIMATE AGAINST THE LUMP SUM APPROPRIATION FUND OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, the proposed construction of streetlights and deep wells have been targeted to be undertaken among others by the City government to promote and enhance the safety, convenience and welfare of the City residents;

WHEREAS, time is of the essence due to the urgency of the above proposed projects, the rising cost of labor and materials, and to avoid unnecessary delay in attending to the normal conduct of public bidding, it is deemed expedient that the City government enters into a negotiated contract for the early completion of the above stated projects;


WHEREAS, pursuant to Section 455 (1) (vi) of RA 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any reputable company for the construction of streetlights and deep wells at such amount of Two Million Five Hundred Thousand Pesos (P2,500,000.00) as cost estimate against the Lump Sum Appropriation fund of the Office of the City Mayor.
