A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF THREE HUNDRED EIGHTY-NINE THOUSAND SIX HUNDRED SEVENTY PESOS AND SEVENTY-FOUR CENTAVOS (P389,670.74) FOR THE CONSTRUCTION OF A RETAINING WALL AT PETINES STREET, BARANGAY BAGONG SILANGAN, TO BE TAKEN FROM THE INFRASTRUCTURE FUNDS OF THE ANNUAL BUDGET OF THE CITY GOVERNMENT.

WHEREAS, residents of Petines St., Bgy. Bagong Silangan, Quezon City, thru Kagawad Crisell Beltran, have expressed their apprehensions of a concrete hollow block wall along Petines St., whose foundation had been eroded by heavy rains and may collapse anytime, thus endangering the lives of the residents and passers-by in the area;

WHEREAS, as per plan, program of work, and detailed estimate prepared by the Office of the City Engineer, the construction of a retaining wall at the subject area in Petines St., will entail the amount of Three Hundred Eighty-Nine Thousand Six Hundred Seventy Pesos and Seventy-Four Centavos (P389,670.74).


