RESOLUTION NO. SP-2200, S-2003

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE ERNESTO LINGA, FORMER BARANGAY CAPTAIN OF BRGY. STA LUCIA, NOVALICHES, THIS CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2003 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY



WHEREAS, the selfless dedication and exemplary services of the late Ernesto Linga deserve appreciation by way of granting financial assistance as a token of gratitude from the City Government to alleviate the financial plight of his bereaved family as a result of his untimely death.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor Feliciano R. Belmonte, Jr., to grant financial assistance to the family and surviving heirs of the late Ernesto Linga, former Barangay Captain of Barangay Sta. Lucia, Novaliches, this City, in the amount of Thirty Thousand Pesos (P30,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions under the 2003 Annual Budget of the Office of the City Mayor or from any available funds in the City Treasury.
