RESOLUTION NO. SP- 2201, S-1003

A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO HIRE A REPUTABLE CONSULTANCY OFFICE TO DO THE PRELIMINARY PLANS AND COST ESTIMATE OF THE PROPOSED MASTER DEVELOPMENT PLAN OF THE QUEZON CITY GENERAL HOSPITAL (QCGH), AND APPROPRIATING THE NECESSARY FUNDS THEREFOR.


WHEREAS, in the exercise of the Quezon City Council's prerogative and to satisfy the aforesaid objective and intention.


NOW, THEREFORE,


