RESOLUTION NO. SP-2204, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO MORE THAN SIXTY (60) FAMILIES AFFECTED BY THE FIRE ON JUNE 9, 2003, THAT RAZED A RESIDENTIAL AREA IN NEW YORK ST. CORNER OXFORD ST., BARANGAY E. RODRIGUEZ AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, local government units are empowered under Section 458 (a) (1) (iv) of RA 7160 "to adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters or calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events";

WHEREAS, a fire razed the houses at the residential area of Barangay E. Rodriguez on June 9, 2003.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., to extend financial assistance to more than Sixty (60) families affected by the fire on June 9, 2003, that razed a residential area in New York St. corner Oxford St., Bgy. E. Rodriguez, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer which shall be taken from the Calamity or Emergency Fund of the City government or from any available fund in the City Treasury.
