A RESOLUTION EXPRESSING FULL SUPPORT FOR THE "UPSCALING URBAN POOR COMMUNITY RENEWAL SCHEME" AND AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PARTNERSHIP OF PHILIPPINE SUPPORT SERVICES AGENCIES, INC., (PHILSSA) FOR THE IMPLEMENTATION OF THE SAID PROJECT FUNDED BY THE WORLD BANK AND JAPAN SOCIAL DEVELOPMENT FUND.
