WHEREAS, the petitioner, Petron Corporation, is applying for the issuance of a Special Use Permit (SUP) for the construction of a gasoline service station to be located at Kalayaan Avenue, Barangay Malaya, Quezon City, classified as a Major Commercial (C-2) Zone;

WHEREAS, gasoline service stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided for in Ordinance No. SP-918, S-2000, otherwise known as the "Quezon City Zoning Ordinance of 2000";

WHEREAS, the petitioner, Petron Corporation, has represented that it has complied with the requirements for the issuance of a Special Use Permit as required Ordinance No. SP-918, S-2000;


WHEREAS, the construction and operation of said gasoline service station will serve to promote public welfare and economic development through the projected increase of employment opportunity in Quezon City.
