RESOLUTION NO. SP **2213**, S-2003

A RESOLUTION URGING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) TO GRANT A CERTIFICATE OF PUBLIC CONVENIENCE TO BATODA TRANSPORT COOPERATIVE TO PLY THE ROUTE EVER-GOTESCO COMMONWEALTH CENTER, LITEX VIA BATASAN ROAD AND VICE-VERSA USING MULTICAB TRANSPORTATION SYSTEM.

Introduced by Councilors ERIC Z. MEDINA, VICTOR V. FERRER, JR., AIKO MELENDEZ, WENCEROM BENEDICT C. LAGUMBAY, ANTONIO E. INTON, JR. and RESTITUTO B. MALAÑGEN.

WHEREAS, recognizing the need for a mass public transport system at the Commonwealth area, the Barangay Council of Barangay Batasan Hills passed a Resolution stating, among others:

"Now therefore, on the motion of the Barangay Council assembled duly seconded by the members of the Council present, resolved as it is hereby resolved to indorse to the Quezon City Council, Quezon City Tricycle Franchising Board and to Land Transportation Franchising and Regulatory Board to award the route line from I.B.P. Road to Ever Gotesco, Commonwealth Branch to BATODA Transport Cooperative to augment the transportation needs of the riding public."

A copy of the Resolution is attached as Annex "A";

WHEREAS, attached to the petition is a sketch of the route to be plied by the applicant cooperative including the letter from the management of EVER GOTESCO allowing the applicant to use a portion of the parking space as their terminal, under certain conditions. A copy is attached as Annexes "B" and "C";

WHEREAS, finding the application for public convenience to be meritorious, not contrary to law and public policy, and for the welfare of the riding public in the Commonwealth area, consisting of Barangay Commonwealth, Batasan Hills, Payatas and Bagong Silangan, thus, this favorable indorsement.



RESOLVED, FURTHER, that copy of this resolution be furnished the Office of the City Mayor for comment and the Land Transportation Franchising and Regulatory Board.

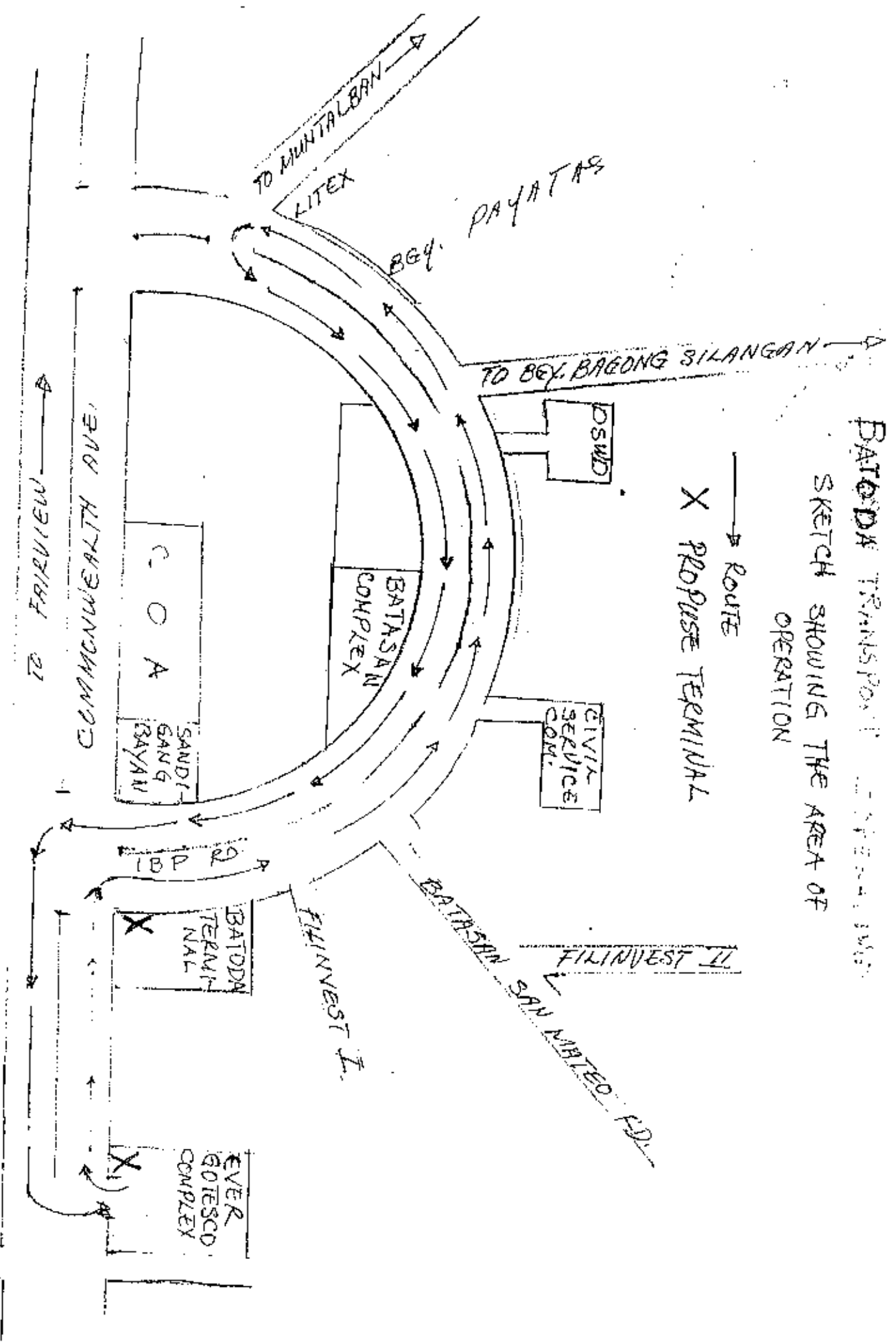
