RESOLUTION NO. SP. 2218, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO ACQUIRE THRU NEGOTIATION AND/OR EXPROPRIATION THAT PARCEL OF LAND WHICH IS BOUNDED ON THE NORTH BY UNIVERSITY AVENUE, ON THE EAST BY CARLOS P. GARCIA, ON THE SOUTH BY A MAN-MADE CREEK AND ON THE WEST BY CULIAT CREEK LOCATED IN BARANGAY SAN VICENTE, QUEZON CITY, TO BE SOLD/AWARDED TO DESERVING AND QUALIFIED OCCUPANTS THEREOF UNDER THE COMMUNITY MORTGAGE PLAN WHERE THE QUEZON CITY AS THE ORIGINATOR.

WHEREAS, the residents of that parcel of land formerly known as the Signal Battalion Philippines Enlisted Men's Barrio located in Barangay San Vicente have for so many years been agitating for an opportunity to own the lots they occupy with the assistance of the authorities concerned;

WHEREAS, Barangay San Vicente has been declared one of the Zonal Improvement Program areas of the City in line with the government's efforts of uplifting living conditions in slum and blighted areas and the eventual land acquisition by the landless residents;

WHEREAS, the residents of Barangay San Vicente have occupied their respective premises that range from 25 to 40 years and have developed and introduced improvements thereon and, therefore, deserve the solicitous concern of the City in pursuance of its responsibility of enhancing the living standard of its people.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, Honorable City Mayor Feliciano R. Belmonte, Jr., to acquire thru negotiation and/or expropriation that parcel of land the boundaries of which are hereinabove defined, located in Barangay San Vicente, Quezon City, and to be sold/awarded to deserving and qualified occupants thereof under the community mortgage plan with Quezon City as the originator.
