RESOLUTION NO. SP- 2223, S-2003

A RESOLUTION STRONGLY URGING HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO CONSIDER THE BUILDING OF ADDITIONAL CLASSROOMS IN DOÑA ROSARIO ELEMENTARY SCHOOL, BARANGAY NOVALICHES PROPER, QUEZON CITY, AND TO ALLOCATE OR APPROPRIATE THE NECESSARY AMOUNT THEREFOR UNDER THE LOCAL SCHOOL BOARD IN THE ANNUAL BUDGET OF THE CITY GOVERNMENT.

WHEREAS, the said insufficiency of classrooms to accommodate the increased enrollment is not conducive to good and facilitative learning and could also jeopardize the health of the studentry if not addressed in due time.
