WHEREAS, the City Engineers Office has a limited number of backhoes, cranes, tractors and similar equipment that barangays have to wait days before their district offices could respond to requests for these equipment whose travel time alone from other project sites to the requesting barangay take hours, at times allowing only a few hours left of actual utilization before they are pulled out again in the afternoon for return to their station;

WHEREAS, the Association of Barangay Chairwomen of Quezon City and the Liga ng mga Barangay of District III have passed resolutions requesting the City government to provide complete engineering equipment to all the four engineering districts of the City.
