A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF SEVENTY SIX THOUSAND NINE HUNDRED ONE PESOS AND SIXTY-THREE CENTAVOS (P76,901.63) FOR THE CONSTRUCTION OF WAITING SHED IN BARANGAY QUIRINO 2-A, QUEZON CITY.

WHEREAS, Section 17 thereof specifically provides that LGU's shall endeavor to provide basic services and facilities intended primarily to service the needs of the residents of the City and which are funded out of City funds which include among others, infrastructure facilities such as multi-purpose hall, pavements, sports center, waiting sheds and other similar facilities;

WHEREAS, the delivery of basic services to our constituents are the primary concern of the Barangay Quirino 2-A Council;

WHEREAS, the riding public are encountering inconveniences in availing public utilities in transporting them to their destinations during rainy or summer seasons;

WHEREAS, waiting shed is the best solution to these inconveniences affecting the riding public.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to allocate the amount of Seventy Six Thousand Nine Hundred One Pesos and Sixty-Three Centavos (P76,901.63) for the construction of waiting shed in Barangay Quirino 2-A, Quezon City.
