RESOLUTION NO. SP-**2228**, S-2003

A RESOLUTION REQUESTING HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR OF QUEZON CITY, TO ALLOCATE THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) TO COVER THE DOWN PAYMENT FOR THE FUTURE SITE OF THE SEAT OF GOVERNMENT OF BARANGAY DAMAYANG LAGI, INCLUDING THE CONSTRUCTION OF CERTAIN INFRASTRUCTURES THEREON, THE AMORTIZATIONS FOR THE BALANCE OF THE PURCHASE PRICE TO BE INCLUDED IN THE BARANGAY BUDGETS.

WHEREAS, the present seat of government of Barangay Damayang Lagi, which occupies the sidewalk and pathwalk along La Felonila Street, will soon be demolished in line with the mandate of the Metro Manila Development Authority (MMDA) to clean all sidewalks and pathways;

WHEREAS, there is a private property consisting of one thousand (1,000) square meters with an improvement thereon which is being offered on a long term payment of Five Thousand Pesos (P5,000.00) and an annual amortization of One Million Pesos (P1,000,000.00);

WHEREAS, the Barangay Council of Barangay Damayang Lagi is willing to include in their Barangay Budgets the annual amortization of One Million Pesos (P1,000,000.00) should the Quezon City government assume the down payment of Five Million Pesos (P5,000,000.00) as required by the owner of the property.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to allocate the amount of Ten Million Pesos (P10,000,000.00) to cover the down payment for the future site of the seat of government of Barangay Damayang Lagi, including the construction of certain infrastructures thereon, the amortization for the balance of the purchase price to be included in the barangay budget.


