RESOLUTION NO. SP **2229** S-2003

A RESOLUTION STRONGLY SUPPORTING THE PROPOSAL OF SENATOR LOREN LEGARDA TO RESTORE THE AMELIORATION PAY IN THE AMOUNT OF SEVEN THOUSAND FIVE HUNDRED PESOS (P7,500.00) OF RANK AND FILE EMPLOYEES OF THE GOVERNMENT TO BOOST THEIR MORALE AND ENABLE THEM TO COPE WITH THE EVER INCREASING PRICES OF BASIC COMMODITIES.

WHEREAS, Senator Loren Legarda has proposed in the Senate the restoration of Amelioration Pay in the amount of Seven Thousand Five Hundred Pesos (P7,500.00) of rank and file employees in the government which was scrapped in 1999 through Executive Order No. 87;

WHEREAS, the restoration of said Amelioration Pay which the rank and file employees of the government used to received before it was scrapped, amounting to the equivalent of one month pay of an ordinary employee, will go a long way to boost the morale of said employee, and provide them with an incentive to improve their efficiency in the performance of their duties;

WHEREAS, there has been an ever increasing rise in the cost of basic commodities, and the restoration of the said amelioration pay will help the rank and file employees cope up with said price increases.
