RESOLUTION NO. SP- **2233**, S-2003

A RESOLUTION URGING QUEZON CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO DIRECT THE CITY ENGINEER TO CAUSE THE DRAINAGE SYSTEM IMPROVEMENT LOCATED AT P.N.B. PROPERTY, BARANGAY PASONG TAMO, DISTRICT II, QUEZON CITY.

WHEREAS, Section 458 (5) (v) of RA 7160, otherwise known as the Local Government Code of 1991, states that, "the sangguniang panlungsod, as the legislative body of the city, shall approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities x x x; regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same;

WHEREAS, there is a felt need to improve the drainage system located at P.N.B. property, Barangay Pasong Tamo, District II, Quezon City, to ease the sufferings of the residents of Lupang Pinagpala Foundation Incorporated, in order to provide for the comfort and convenience of the residents of said barangay;


WHEREAS, the City Engineer has estimated that the project will cost Eight Hundred Thirty Three Thousand Five Hundred Thirty-Eight Pesos and Thirty One Centavos (P833,538.31) which includes the removal of existing structures, excavation, installation of drainage system, which amount is not available in any existing appropriation.
