WHEREAS, Section 472 of the Local Government Code provides that the appointment of an assessor shall be mandatory for the provincial, city and municipal governments;

WHEREAS, Section 454 (d), of the same Code, likewise provides that "unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the sangguniang panlungsod members, subject to civil service law, rules and regulations";

WHEREAS, the confirmation of the appointment of Mrs. Teofista L. Pajara as City Assessor of Quezon City, will complete the substantive and procedural requirement set forth by the Civil Service Rules regarding the appointment of this nature;

WHEREAS, Mrs. Teofista L. Pajara is the concurrent Officer-in-charge (OIC) of the Office of the City Assessor of the Quezon City government.


