A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO THE VICTORY LINER INCORPORATED FOR THE OPERATION OF SERVICE CENTER (MOTORPOOL) LOCATED AT LOT 1, BLOCK 78, 322 BALER STREET, BARANGAY PALTOK, QUEZON CITY.


WHEREAS, the construction and operation of said service center (motorpool) will promote public welfare and economic development through the projected increase of employment opportunity in Quezon City.
