RESOLUTION NO. SP-2245, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT/DEED OF USUFRUCT WITH THE SENIOR CITIZENS ASSOCIATION, SAN BARTOLOME (NOVA) CHAPTER, INC., NOVALICHES, QUEZON CITY, FOR THE USE OF AN AVAILABLE CITY-OWNED PARCEL OF LAND SITUATED IN BARANGAY SAN BARTOLOME, NOVALICHES, QUEZON CITY, COMPRISING OF TWO HUNDRED (200) SQUARE METERS, MORE OR LESS, FOR THE PUTTING-UP/CONSTRUCTION OF ITS MULTI-PURPOSE BUILDING.
