WHEREAS, Resolution No. SP-1976, S-2002, authorized Hon. City Mayor Feliciano R. Belmonte, Jr., to enter into a negotiated contract with Greenlights Construction for the construction of streetlightings, basketball boards with goal and deep wells, in the amount of One Million Six Hundred Fifty Six Thousand Pesos (P1,656,000.00) to be charged against the Lump Sum Appropriation of Fund of the Office of the City Mayor;

WHEREAS, the above-mentioned resolution was finally passed by the City Council on December 17, 2002 and consequently signed by the Honorable Presiding Officer, Vice Mayor Herbert M. Bautista;

WHEREAS, the subject contract did not push through for reason that the company aforecited is not accredited by the City;

WHEREAS, because time is of the essence due to the urgency of the proposed projects, the rising cost of labor and materials, and in order to avoid unnecessary delay in attending to the normal conduct of public bidding, it is deemed expedient that City government enter into a negotiated contract with any reputable and City accredited company for the early completion of the above stated projects.


