RESOLUTION NO. SP- 2250, S-2003

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO GRANT APPROPRIATE EXTENSION OF TIME TO STAY FOR THE PRESENT OCCUPANTS/RESIDENTS OF PALANZA AND T. ARGUELLES STREETS WHICH IS A SIDEWALK AND/OR OWNED BY THE CITY GOVERNMENT, LOCATED AT BARANGAY SANTOL, AREA 22, DISTRICT IV, QUEZON CITY, AND THEREAFTER RELOCATE THEM AT A PLACE DECENT AND HABITABLE AND FOR OTHER PURPOSES ON THE BASIS OF HUMANITARIAN REASONS.

WHEREAS, the Constitution under the Bill of Rights provides among others that no person shall be deprived of life, liberty and property without due process of law;

WHEREAS, there are at least around fifty (50) families presently occupying a certain parcel of lot which is a sidewalk and belonging to the government and residing thereat as residents and some of them have been staying in the aforesaid place for more than ten (10) continuous years;

WHEREAS, these occupants are now the subject of a summary ejectment;

WHEREAS, almost all of the occupants/residents have children enrolled in the different public schools, either in elementary, secondary and tertiary courses, studying and as a consequence, despite the hardship in life, seek education for brighter future;

WHEREAS, the occupants will not object to said ejection/demolition, but invoking humanitarian and other reason, seek extension of appropriate time to stay in the said place until such time at present calendar year expire and/or until June 2004;

WHEREAS, recognizing that these occupants are human being, this representation firmly believes that before such ejection/demolition, a relocation for them to live at a decent and habitable place is most deserving and glory.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby strongly request, the Honorable City Mayor, Feliciano R. Belmonte, Jr., to grant appropriate extension of time to stay for the present occupants/residents of Palanza and T. Arguelles Streets which is a sidewalk and/or owned by the City government, located at Barangay Santol, Area 22, District IV, Quezon City and thereafter relocate them at a place decent and habitable and for other purposes on the basis of humanitarian reasons.
