RESOLUTION NO. SP- **2255**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY OF THE REPUTABLE AND ACCREDITED CONTRACTORS TO UNDERTAKE VARIOUS INFRASTRUCTURE PROJECTS IN DIFFERENT BARANGAYS IN DISTRICT IV, QUEZON CITY.

WHEREAS, some of the barangay officials in District IV, Quezon City, requested to undertake infrastructure projects in their barangays;

WHEREAS, the Office of the City Engineer conducted an ocular inspection on the site of the proposed projects;

WHEREAS, the Office of the City Engineer prepared and submitted a Program of Work and Detailed Estimate for the proposed projects located in the following barangays:

1. Proposed concreting of Biak na Bato Street, Barangay Sto. Niño;
2. Proposed construction of two (2) storey multi-purpose hall with roofdeck and mezzanine (Phase II) Barangay Botocan;
3. Proposed construction of multi-purpose hall at PZBG Compound, Barangay Central; and
4. Proposed construction of waiting shed at C. Benitez Street corner P. Tuazon Street, Barangay Kaunlaran.

WHEREAS, it is necessary for the City Council to grant authority to the City Mayor in order for the latter to enter into a negotiated contract with any reputable and accredited contractors to implement said proposed projects in different barangays in District IV.


NOW, THEREFORE,
