RESOLUTION NO. SP- **2256**, S-2003

A RESOLUTION REQUESTING HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR. TO ALLOCATE THE AMOUNT OF FIFTY-ONE THOUSAND NINE HUNDRED FIFTY-EIGHT PESOS AND FORTY-SEVEN CENTAVOS (P51,958.47) FROM THE INFRASTRUCTURE FUND OF THE 2003 ANUAL CITY BUDGET FOR THE INSTALLATION OF ONE (1) ARTESIAN WELL IN PUROK 2, BARANGAY BAGONG SILANGAN, QUEZON CITY.

WHEREAS, Section 458 (5) (vii) of the Local Government Code of 1991, empowers the City Council of Quezon City to establish and provide for the maintenance, repair and operation of an efficient waterworks system to supply water to the inhabitants;

WHEREAS, the residents of Purok 2, Filside Bagong Silangan have no adequate source of water for their daily needs and requested the assistance of the City government for the installation of a deepwell in their area;


WHEREAS, as per Cost Estimate and Program of Work prepared by the Office of the City Engineer, the installation of the requested artesian well costs Fifty-One Thousand Nine Hundred Fifty-Eight Pesos and Forty-Seven Centavos (P51,958.47).
