RESOLUTION NO. SP- **2257**, S-2003

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE FORMER BARANGAY CAPTAIN ANTONIO A. ANCHETA OF BARANGAY FAIRVIEW, WHO DIED LAST AUGUST 3, 2003, DUE TO LUNG CANCER IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2003 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.




