A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND AMONG THE QUEZON CITY GOVERNMENT REPRESENTED BY HONORABLE CITY MAYOR FELICIANO R. BELMONTE JR., EUROCREDIT COOPERATIVE REPRESENTED BY ITS PRESIDENT, ATTY. ALFEO D. VIVAS, AND THE NATIONAL LIVELIHOOD SUPPORT FUND REPRESENTED BY ITS EXECUTIVE DIRECTOR, MR. ANTONIO Y. ORTIZ, TO IMPLEMENT THE PUHUNANG PANGKAUNLARAN NG SIKAP BUHAY (PPSB)-EUROCREDIT, A MICRO-ENTERPRISE FINANCING PROGRAM FOR QUEZON CITY, DOCKETED AS DOCUMENT NO. 745, PAGE NO. 148, BOOK NO. 1 SERIES OF 2003 OF THE NOTARIAL REGISTER OF NOTARY PUBLIC, ATTY. WHEREAS, on August 20, 2003, the Eurocredit Corporation represented by its President, Atty. Alfeo D. Vivas, the Quezon City government represented by the City Mayor, Honorable Feliciano R. Belmonte, Jr., and the National Livelihood Support Fund represented by its Executive Director, Mr. Antonio Y. Ortiz, entered into a Memorandum of Agreement whereby they have agreed to jointly collaborate and implement a micro-enterprise financing program for selected resident-beneficiaries of Quezon City, referred to as the Puhunang Pangkaunlaran ng Sikap Buhay (PPSB)-EUROCREDIT, which document was entered as Doc.
