RESOLUTION NO. SP- **2260**, S-2003

A RESOLUTION URGING THE CITY TREASURER, DR. VICTOR B. ENDRIGA, TO STRICTLY ENFORCE THE PROVISIONS OF ORDINANCE NO. SP-91, S-93, OTHERWISE KNOWN AS THE QUEZON CITY REVENUE CODE OF 1993, ON THE IMPOSITION AND COLLECTION OF REAL PROPERTY TAX PARTICULARLY ON AUTOMATED TELLER MACHINES (ATMs).

WHEREAS, in order to raise the City revenue collection, there is a need to strictly enforce the provisions of the Quezon City Revenue Code;

WHEREAS, one of the main sources of revenues is the tax imposed on real properties such as lands, buildings, machineries and other improvements thereon in Quezon City;

WHEREAS, Quezon City being still a manufacturers City imply machineries which are taxable, could hardly collect taxes for machineries;

WHEREAS, there is a need to intensify the levying of taxes on machineries particularly Automated Teller Machines (ATMs);


WHEREAS, pursuant to the Quezon City Revenue Code of 1993, the collection of real property tax x-x-x and the enforcement of the remedies provided in the Code or any applicable laws is the responsibility of the City Treasurer.
