A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO DIRECT THE QUEZON CITY ENVIRONMENTAL PROTECTION AND WASTE MANAGEMENT DEPARTMENT TO FACILITATE THE INSTALLATION OF A TEXT MESSAGING SYSTEM OR "TEXT BASURA" WITHIN THE CITY IN ORDER TO EFFECTUATE A SPEEDY AND EFFICIENT GARBAGE COLLECTION THEREIN.

WHEREAS, Quezon City for its part is under obligation to protect the environment by immediately responding and monitoring all concerned constituents who do care and report the uncollected garbage in a short period of time as possible.




