RESOLUTION NO. SP- **2263**, S-2003

A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO DISPOSE BY WAY OF DONATION PARK STRIP B AND ROAD LOT 9, UNDER PSD-10781, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 267513, WITH A TOTAL AREA OF NINE HUNDRED THIRTY-SEVEN SQUARE METERS (937 SQ.M.), AND SITUATED IN BARANGAY NAYONG KANLURAN, QUEZON CITY, UNDER SUCH TERMS AND CONDITIONS AS MAY BE JUST AND REASONABLE UNDER THE CIRCUMSTANCES.

WHEREAS, the Quezon City government is the owner of the parcel of land covered by Transfer Certificate of Title No. 267513 located at Barangay Nayong Kanluran, Quezon City, with a total area of Nine Hundred Thirty-Seven square meters (937 sq. m.);

WHEREAS, the said barangay has requested for the acquisition of the subject public property hosting present and existing barangay structures, such as 1) barangay basketball court, 2) wet market, 3) day-care center with playground, 4) satellite health center, and 5) barangay hall;

WHEREAS, the roads and alleys shall not be included in the donation and will remain under the name of the Quezon City government;

WHEREAS, said Barangay Council is now soliciting the benevolence and assistance of the City Mayor and the Sangguniang Panlungsod to allow them to acquire the said land directly from the Quezon City government thru a possible donation.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, his Honor, City Mayor Feliciano R. Belmonte, Jr., to dispose by way of donation Park Strip B and Road Lot 9, under PSD-10781, covered by Transfer Certificate of Title No. 267513, with a total area of Nine Hundred Thirty-Seven square meters (937 sq.m.), and situated in Barangay Nayong Kanluran, Quezon City, under such terms and conditions as may be just and reasonable under the circumstances.

RESOLVED, FURTHER, to furnish the Honorable City Mayor and the Barangay Nayong Kanluran with copies of this Resolution.
