RESOLUTION NO. SP- 2265, S-2003

A RESOLUTION CALLING FOR THE CREATION OF AN EFFECTIVE CITY PROCUREMENT SYSTEM TO AVOID PRICE MANIPULATION OR OVER PRICING THROUGH AN ON-LINE BIDDING OF CONTRACTORS AND SUPPLIERS WITH SET PRICE CEILINGS.

WHEREAS, pursuant to Section 5 of Republic Act 7581, otherwise known as the "Price Act" of 1992, provides that, "Without prejudice to the provision of existing laws on goods not covered by this Act, it shall be unlawful for any person habitually engaged in the production, manufacture, importation, storage, transport, distribution, sale or other methods of disposition of goods to engage in the following acts of price manipulation of the price of any basic necessity or prime commodity; x x x";

WHEREAS, a lot of critics say that there is corruption in the Procurement System of almost all government offices because of over pricing;

WHEREAS, having an on-line bidding with set price ceilings will hopefully eliminate or at least minimize this in Quezon City;

WHEREAS, at the same time, having many competitors participating in the bidding will lead to lower prices.
