RESOLUTION NO. SP- **2266**, S-2003

A RESOLUTION URGING THE CITY MAYOR TO APPROPRIATE THE AMOUNT OF SIX MILLION FOUR HUNDRED THOUSAND PESOS (P6,400,000.00) FOR THE IMPROVEMENT OF THE DRAINAGE SYSTEM AT GOVERNOR STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY.

WHEREAS, Mr. Jose "Lito" Sevilla, President of Sta. Monica Village Homeowners Association, Barangay Gulod, Quezon City, in his letter dated March 14, 2003 addressed to his Honor, Mayor Feliciano R. Belmonte, Jr., expressed their predicament over the clogged drainage system at Governor Street in the said barangay;

WHEREAS, in the 1st Indorsement dated March 17, 2003 of City Engineer Joselito B. Cabungcal, he recommended the amount of Six Million Three Hundred Forty Thousand Five Hundred Ninety-Nine Pesos and Sixty One Centavos (P6,340,599.61) as cost estimate for the improvement of the said drainage system;


WHEREAS, to lessen the burden of the residents in the area, especially during rainy season, and to prevent loss of lives, there is a need to appropriate funds for the said project.


