A RESOLUTION CONDEMNING THE SENSELESS MURDER OF BARANGAY CHAIRMAN RODRIGO M. BORGONIA OF BARANGAY PANSOL, DISTRICT III, THIS CITY, AND CALLING FOR THE SPEEDY INVESTIGATION OF SUCH HEINOUS ACT BY OUR LOCAL POLICE AUTHORITIES.



WHEREAS, this dastardly act is definitely a severe blow dealt to our pursuit of giving genuine public service to our constituents.










NOW, THEREFORE,
