RESOLUTION NO. SP- **2268** , S-2003

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF SIXTY-FOUR THOUSAND NINE HUNDRED NINETY PESOS (P64,990.00) FOR THE INSTALLATION OF ONE (1) MERALCO POST AT 119 P. DELA CRUZ STREET, BARANGAY SAN BARTOLOME, QUEZON CITY, TO BE TAKEN FROM THE INFRASTRUCTURE FUND OF THE 2003 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, the Pag-asang Samahan ng Magkakapitbahay sa 119 P. Dela Cruz Street, Homeowners Association, Inc., of Barangay San Bartolome, this City, in a letter dated July 21, 2003, duly endorsed by Barangay Captain Rolando P. Dela Cruz, requested the assistance of the City government through the proponent for the installation of one (1) Meralco post in their area;

WHEREAS, the early installation of the requested Meralco post is necessary in order to align the unsightly and criss-crossing electrical wirings/connections in the subject area to preclude the occurrence of short circuits which are common causes of fires/conflagrations inimical to the safety, well-being and welfare of the constituents;


WHEREAS, based on the project study conducted by Meralco, Novaliches, the cost estimate for the said post installation is Sixty-Four Thousand Nine Hundred Ninety Pesos (P64,990.00) but the members of the above-mentioned homeowners' association being mostly indigent could not raise the amount needed therefor, hence the request for financial assistance from the City government for the project to be given due course by Meralco.
