RESOLUTION NO. SP 2274S-2003

A RESOLUTION STRONGLY URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE AMOUNT OF FIFTY-ONE THOUSAND NINE HUNDRED FIFTY-EIGHT PESOS AND FORTY-SEVEN CENTAVOS (P51,958.47) FOR THE CONSTRUCTION/INSTALLATION OF AN ARTESIAN WELL AT TAWID SAPA I, BARANGAY SAN AGUSTIN, THIS CITY, TO BE TAKEN FROM THE INFRASTRUCTURE FUND OF THE ANNUAL CITY BUDGET.

WHEREAS, the Samahang Magkakapitbahay ng Tawid Sapa I, Phase 1, Homeowners Association Inc., Barangay San Agustin, Novaliches, Quezon City (SMAGTASA), requested the assistance of the City government for the installation of an artesian well in their area for the common use of all the residents therein;

WHEREAS, as per Cost Estimate and Program of Work submitted by the Office of the City Engineer, the amount of Fifty One Thousand Nine Hundred Fifty-Eight Pesos and Forty-Seven Centavos (P51,958.47) is needed to construct/install the artesian well in the area.




