RESOLUTION NO. SP **2275** S-2003

A RESOLUTION STRONGLY URGING THE LOCAL SCHOOL BOARD TO INCLUDE IN THE ANNUAL SCHOOL BOARD BUDGET AN APPROPRIATION SUFFICIENT TO MEET THE COST OF BUILDING/ESTABLISHING AND MAINTAINING ADDITIONAL CLASSROOMS IN BAGONG PAG-ASA ELEMENTARY SCHOOL, BARANGAY BAGONG PAG-ASA, DISTRICT 1, QUEZON CITY.

WHEREAS, there is in every city a Local School Board tasked to supervise and maintain the operation of all public schools within its area of jurisdiction;

WHEREAS, Section 99 of the Local Government Code of 1991, provides:

"Functions of Local School Boards - The provincial, city or municipal school board shall:

- (a) Determine, in accordance with the criteria set by the Department of Education, Culture and Sports, the annual supplementary budgetary needs for the operation and maintenance of public school within the province, city or municipality, as the case may be, and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget x x x."

WHEREAS, the Bagong Pag-asa Elementary School in Barangay Bagong Pag-asa, District 1, this City, is suffering from insufficiency of classrooms due to the yearly increase in the number of elementary enrollees;

WHEREAS, there is an urgent need to provide additional classrooms in the said school in order to accommodate the students.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the Local School Board to include in the Annual School Board Budget an appropriation sufficient to meet the cost of building/establishing and maintaining additional classrooms in Bagong Pag-asa Elementary School, Barangay Bagong Pag-asa, District 1, Quezon City.
