RESOLUTION NO. SP-**2277**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE CONTRACTOR FOR THE DAILY SUSTENANCE OF THE INMATES JAILED AND/OR DETAINED AT THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) FACILITY IN QUEZON CITY.

WHEREAS, the City government is responsible for the provision of the daily food sustenance of an estimated two thousand six hundred (2,600) inmates jailed and/or detained at the Bureau of Jail Management and Penology facility in Quezon City;

WHEREAS, there is no material time to procure the aforementioned food requirement through public bidding, hence, an estimated amount is appropriated for that purpose;

WHEREAS, the Lorca's Bakery and Merchandiser, a corporation engaged in catering business duly licensed and accredited by the City with office address at 1090 Del Monte Avenue, Quezon City, and herein respresented by its Manager/Proprietor Leticia E. Lorca has been recommended by the Quezon City General Services Officer, City Treasurer undertake the food requirement of the City Jail;

WHEREAS, the City Mayor has approved the recommendation awarding the said contract to the Lorca's Bakery and Merchandiser;

WHEREAS, pre-signed copy of the Negotiated Contract is hereto attached as Annex "A";


