A RESOLUTION ACCEPTING THE TWO MILLION PESO (P2.000,000.00) ASSISTANCE FUND/GRANT FROM THE OFFICE OF SENATOR RAMON B. MAGSAYSAY, JR., FOR THE BANTAY-USOK PROGRAM OF ABS-CBN FOUNDATION (BANTAY-KALIKASAN).

Magsaysay, Jr., for the Two Million Peso (P2,000,000.00) assistance fund/grant for its Bantay Usok Program, to monitor air quality and pollution control;

WHEREAS, ABS-CBN Foundation has chosen Quezon City as the local government conduit through which the said funds are to be released;

WHEREAS, in 1998, Quezon City organized its Anti-Smoke Belching Unit to enforce its Anti-Smoke Belching Program, now directly under the Pollution Control Division of the Environment Protection and Waste Management Department;

WHEREAS, the Quezon City government will benefit from grants and financial assistance from available sources in implementing its programs and projects and delivering services for the residents of the City, more especially, in ensuring their health and welfare.
