RESOLUTION NO. SP- **2282**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH A DULY ACCREDITED CONTRACTOR FOR THE INSTALLATION OF BASKETBALL BOARDS, INSTALLATION OF MOVABLE GARBAGE SEGREGATION RECEPTACLES AND INSTALLATION OF TRAFFIC SIGNS, AT SUCH AMOUNT NOT EXCEEDING ITS COST ESTIMATE TO BE CHARGED AGAINST LUMP SUM APPROPRIATION FUND (CAPITAL OUTLAY-INFRASTRUCTURE FUND) OF THE CITY COUNCIL.

WHEREAS, the installation of basketball boards, installation of movable garbage segregation receptacles, installation of traffic signs have been targeted to be undertaken, among others, by the City government to promote and enhance the convenience and welfare of the City residents, to wit:

Installation of Basketball Boards	P1,420,470.00
Installation of Movable Garbage Segregation Receptacles	538,655.22
Installation of Traffic Signs	537,851.58

WHEREAS, time is of the essence due to the urgency of the above proposed projects, the rising cost of labor and materials and to avoid unnecessary delay in attending to the normal conduct of public bidding, it is deemed expedient that the City government enter into a negotiated contract for the early completion of the above-stated projects:



WHEREAS, Section 455 (b)(1)(vi) of R.A. 7160, otherwise known as the "Local Government Code of 1991," provides that the city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations; and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance".


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor Feliciano R. Belmonte, Jr., to enter into a negotiated contract with a duly accredited contractor for the installation of basketball boards, installation of movable garbage segregation receptacles, and installation of traffic signs, at such amount not exceeding its cost estimate to be charged against the Lump Sum Appropriation Fund (Capital Outlay-Infrastructure Fund) of the City Council.
