A RESOLUTION REQUESTING HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO UNDERTAKE CERTAIN INFRASTRUCTURE PROJECTS IN KAMUNING ELEMENTARY SCHOOL, DISTRICT IV, THE AMOUNT NECESSARY THEREFOR TO BE TAKEN EITHER FROM THE SCHOOL BOARD FUND OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

1. Installation of new pipes for water supply;
2. General repair of toilets;
3. Minor repairs and repainting of school building;
4. Heightening of the perimeter fence;
5. General repair of the stage of the school; and
6. Construction of the Industrial Arts Building.
