RESOLUTION NO. SP- 2288, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE CONTRACTOR FOR THE REHABILITATION AND IMPROVEMENT OF THE DRAINAGE AND OPEN CANAL ALONG AGNO STREET UP TO THE CORNER OF D. TUAZON AVENUE, BARANGAY DOÑA JOSEFA, QUEZON CITY, TO BE TAKEN FROM ANY AVAILABLE FUNDS FROM THE OFFICE OF THE CITY MAYOR.

WHEREAS, pursuant to Section 455 (b)(1)(vi) of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that "the city mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations; and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance."
