RESOLUTION NO. SP- **2292**, S-2003

A RESOLUTION REQUESTING HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO ALLOCATE FROM ANY AVAILABLE FUNDS OF THE CITY THE SUM OF FIVE MILLION SIX HUNDRED SEVENTY-EIGHT THOUSAND SIX HUNDRED THIRTY PESOS (P5,678,630.00), FOR THE IMPROVEMENT/CONCRETING OF ACACIA STREET, INCLUDING ITS SIDEWALK FROM ROSARIO TO BALETE DRIVE LOCATED IN BARANGAY MARIANA, DISTRICT IV, QUEZON CITY.

WHEREAS, the Office of the City Engineer has submitted a Plan/Program of Work and Detailed Estimate of the proposed project in the amount of Five Million Six Hundred Seventy-Eight Thousand Six Hundred Twenty-Nine Pesos and Ten Centavos (P5,678,629.10);

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, Honorable Feliciano R. Belmonte, Jr., City Mayor, Quezon City, to allocate from any available funds of the City the sum of Five Million Six Hundred Seventy-Eight Thousand Six Hundred Thirty Pesos (P5,678,630.00), for the improvement/concreting of Acacia Street, including its sidewalk from Rosario to Balete Drive located in Barangay Mariana, District IV, Quezon City.
