RESOLUTION NO. SP- **2298**, S-2003

A RESOLUTION RATIFYING THE BIDDING DOCUMENTS PREPARED FOR SECURITY SERVICES AS PROPOSED BY THE CITY GENERAL SERVICES OFFICE.

WHEREAS, the provision of protective and security services over vital installations, facilities and personnel of Quezon City government is essential if we expect an efficient delivery of public and community services;

WHEREAS, the City Legal Department has proposed changes to the bidding documents, foremost of which is the submission of individual drug test results and NBI/Police clearances for each security guard to be assigned to the Quezon City government in an effort to ensure faithful and strict compliance to the terms and conditions of providing security services;

WHEREAS, the City government is empowered to contract out security and protective services to qualified contractors, who must prove that they possess the necessary qualifications, to be determined by the Committee on Awards.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as if does hereby ratify, the bidding documents for security services, as proposed by the City General Services Office.


