A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO DIRECT THE HOUSING AND URBAN RENEWAL AUTHORITY (HURA) TO PURCHASE THE REAL PROPERTY OWNED BY SOLID MILLS, INC., LOCATED IN BARANGAY DOÑA IMELDA, DISTRICT IV, QUEZON CITY, FOR HOUSING PROJECT FOR THE CITY GOVERNMENT EMPLOYEES AND THE ACTUAL OCCUPANTS THEREOF.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to direct the Housing and Urban Renewal Authority (HURA) to purchase from Solid Mills, Inc., Lot 14, Block 598, located in Palanza Street, Barangay Doña Imelda, District IV, Quezon City, to be utilized as housing project, one-half for city government employees and the other half for the actual occupants thereof.
