RESOLUTION NO. SP-**2316**, 9-2003

A RESOLUTION AUTHORIZING QUEZON CITY VICE MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A NEGOTIATED CONTRACT WITH A REPUTABLE CONTRACTOR FOR THE ASPHALTING OF ROADS, CONSTRUCTION OF WAITING SHEDS, INSTALLATION AND FABRICATION OF BASKETBALL BOARDS, CONSTRUCTION OF MULTI-PURPOSE HALLS, IMPROVEMENT OF SCHOOL PREMISES IN DIFFERENT BARANGAYS LOCATED IN THE SECOND DISTRICT OF QUEZON CITY, IN THE AMOUNT NOT EXCEEDING TWO MILLION FIVE HUNDRED THOUSAND PESOS (P2,500,000.00) TO BE CHARGED AGAINST THE CAPITAL OUTLAY FOR PUBLIC INFRASTRUCTURE/ OTHER STRUCTURES OF THE QUEZON CITY COUNCIL'S BUDGET FOR 2004.

WHEREAS, the asphaltting of roads, construction of waiting sheds, installation and fabrication of basketball boards, construction of multi-purpose halls, improvement of school premises in the different barangays located in the second district of Quezon City are among the priority development projects of the Quezon City government;

WHEREAS, such developmental projects are aimed to provide easy, convenient and more comfortable facilities to the residents of second district of Quezon City;

WHEREAS, time is of the essence in the implementation of said projects in the face of beautification of every barangay and other factors affecting the early completion of said projects;

WHEREAS, there is a sense of urgency, and a felt need to immediately finish said projects in order to provide comfort and convenience to the residents of said barangays;

WHEREAS, in order to avoid unnecessary delay which normally attends in public bidding, there is a felt need to authorize the City Vice Mayor of Quezon City, Honorable Herbert M. Bautista, to enter into a negotiated contract with a reputable contractor for the asphaltting of roads, construction of waiting sheds, installation and fabrication of basketball boards, construction of multi-purpose halls, improvement of school premises in the different barangays of the second district of Quezon City.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Vice Mayor Herbert M. Bautista, to enter into a negotiated contract with a reputable contractor for the asphaltting of roads, construction of waiting sheds, installation and fabrication of basketball boards, construction of multi-purpose halls, improvement of school premises in the different barangays of second district of Quezon City in an amount not exceeding Two Million Five Hundred Thousand Pesos (P2,500,000.00) to be charged against the Capital Outlay for Public Infrastructure/Other Structures of Quezon City Council's budget for 2004.


