A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., QUEZON CITY MAYOR, TO PURCHASE THE ONE THOUSAND (1,000) SQUARE METER PROPERTY SITUATED AT BARANGAY OLD BALARA, FOR DIRECT SALE UNDER THE DIRECT SALE PROGRAM OF THE GOVERNMENT TO THE CURRENT OCCUPANTS AND MEMBERS OF THE MAGKAKASAMA HOMEOWNERS ASSOCIATION, INC. UNDER THE COMMUNITY MORTGAGE PROGRAM (CMP).

WHEREAS, subject occupants are within the economic category that would qualify for housing loan entitlement in the Community Mortgage Program.


NOW, THEREFORE,
