RESOLUTION NO. SP-**2318** S-2003

A RESOLUTION URGING THE CIVIL SERVICE COMMISSION TO STRICTLY ENFORCE THE PROVISIONS OF REPUBLIC ACT NO. 6713, OTHERWISE KNOWN AS THE CODE OF CONDUCT AND ETHICAL STANDARDS FOR PUBLIC OFFICIALS AND EMPLOYEES, MORE PARTICULARLY THE PROVISION THEREOF REQUIRING PROMPT ACTION BY PUBLIC OFFICIALS AND EMPLOYEES ON PAPERS PENDING BEFORE THEM.

Introduced by Councilors BERNADETTE HERRERA-DY, DANTE M. DE GUZMAN, WILMA AMORANTO-SARINO, RAMON P. MEDALLA, ERIC Z. MEDINA, MARY ANN L. SUSANO, JORGE L. BANAL, JULIAN M.L. COSETENG, JESUS MANUEL C. SUNTAY and RESTITUTO B. MALAÑGEN.

WHEREAS, the Code of Conduct and Ethical Standards for Public Officials and Employees was promulgated mainly to uphold the time-honored principle that "a public office is a public trust";

WHEREAS, notwithstanding the existence of said Code, there are still public officials and employees in the government who fail or refuse to act promptly on papers pending before them for official action;

WHEREAS, said public officials and employees are giving a serious "black-eye" to the public service and have encouraged people to lose faith in their government;

WHEREAS, the Civil Service Commission has been designated in said Code as the agency having "the primary responsibility for the administration and enforcement" of the provisions thereof.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Civil Service Commission to strictly enforce the provisions of Republic Act No. 6713 otherwise known as the Code of Conduct and Ethical Standards for Public Officials and Employees, more particularly the provision thereof requiring prompt action by public officials and employees on papers pending before them.
