A RESOLUTION STRONGLY URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., FOR THE CONTINUANCE OF THE OPERATION OF QUIRINO HIGH SCHOOL, PURA V. KALAW ANNEX, LOCATED AT SALALILLA STREET, PROJECT 4, QUEZON CITY.

WHEREAS, Project 4 covers thirteen (13) barangays with four (4) elementary schools and only one high school (Jose P. Laurel Sr. High School). It is impossible to accommodate all graduates coming from the elementary schools;

WHEREAS, there is a strong clamor by the residents to establish a high school in the area in order to accommodate all elementary graduates;

WHEREAS, the Pura V. Kalaw Elementary School, in line with the growing need for the education of all youth, has expanded its program, and as of last year, has adopted a high school, although only in the first and second year only and treated as an annex of the Quirino High School;

WHEREAS, there is a felt need for the continuation of the existence of a secondary level high school at Pura V. Kalaw Annex.


