Among his notable achievements in the GSIS was the streamlining of its operations and revival of the System's financial viability;

Enriquez, Jr. was appointed to head the Department of Budget and Management (1990-1998) and Department of Finance with an astounding record of strengthening the country's financial position by reforming the government's fiscal management policy, thus resulting to a reduced national budget deficit;


NOW, THEREFORE,
