RESOLUTION NO. SP **2328**S-2003

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE QUEZON CITY GOVERNMENT WITH THE QUEZON CITY PUBLIC SCHOOL TEACHERS ASSOCIATION AND THE ALLIANCE OF CONCERNED TEACHERS-PHILIPPINES, INC., FOR THE CONSTRUCTION OF A MULTI-PURPOSE BUILDING TO HOUSE THE OFFICES OF THE TWO (2) TEACHERS' ORGANIZATIONS.

WHEREAS, the Quezon City Government, thru the City Mayor, Honorable Feliciano R. Belmonte, Jr., intends to enter into a Memorandum of Agreement with the Quezon City Public School Teachers Association, represented by its President, Ms. Francisca Castro and the Alliance of Concerned Teachers-Philippines, Inc., represented by its National Chairman, Mr. Antonio Tinio, for the construction of a Multi-Purpose Building to house the offices of the two (2) teachers' organizations.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, Honorable Feliciano R. Belmonte, Jr., to enter into a Memorandum of Agreement for and in behalf of the Quezon City Government with the Quezon City Public School Teachers Association and the Alliance of Concerned Teachers-Philippines, Inc., for the construction of a Multi-Purpose Building to house the offices of the two (2) teachers' organizations.
