RESOLUTION NO. SP-2329 S-2003

A RESOLUTION ATHORIZING QUEZON CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT HTIW A REPUTABLE CONTRACTOR ASPHALTING OF ROADS, CONSTRUCTION OF WAITING SHEDS, CONSTRUCTION OF. MULTI-PURPOSE HALLS. REPAIR IMPROVEMENT OF SCHOOL PREMISES AT VARIOUS BARANGAYS IN DISTRICT II, QUEZON CITY, IN AN AMOUNT NOT EXCEEDING TWO MILLION FIVE HUNDRED THOUSAND PESOS (P2,500,000,00) TO BE CHARGED AGAINST THE LUMP SUMP APPRORIATION FUND UNDER THE OFFICE OF THE CITY MAYOR FOR 2004.

Introduced by Councilor VOLTAIRE GODOFREDO L. LIBAN III.

WHEREAS, the asphalting of roads, construction of waiting sheds, construction of multi-purpose halls, repair and improvement of school premises at various barangays in District II, Quezon City, are among the priority development projects of Quezon City government;

WHEREAS, such developmental projects are aimed to provide easy, convenient and more comfortable facilities to the residents of second district of Quezon City;

WHEREAS, time is of the essence in the implementation of said project in the face of beautification of every barangay and other factors affecting the early completion of said projects;

WHEREAS, there is a sense of urgency, and a felt need to immediately finish said projects in order to provide comfort and convenience to the residents of said barangays;

WHEREAS, in order to avoid unnecessary delay which normally attends in public bidding, there is a felt need to authorize the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract with a reputable contractor for the asphalting of roads, construction of waiting sheds, construction of multi-purpose halls, repair and improvement of school premises at various barangays in District II, Quezon City;

Belmonte, Jr., to enter into a negotiated contract with a reputable contractor for the asphalting of roads, construction of waiting sheds, construction of multi-purpose halls, repair and improvement of school premises at various barangays in District II, Quezon City, in an amount not exceeding Two Million Five Hundred Thousand Pesos (P2,500,000.00) to be charged against the Lump Sum Appropriation Fund under the Office of the City Mayor for 2004.
