A RESOLUTION AUTHORIZING THE CITY TREASURER, MR. VICTOR B. ENDRIGA TO REQUEST FOR THE PRINTING OF PERSONALIZED/CUSTOMIZED ACCOUNTABLE FORMS AND RECEIPTS FROM THE OFFICE OF THE PRESS SECRETARY, NATIONAL PRINTING OFFICE, AS MANDATED BY EXECUTIVE ORDER NO. 285 FOR ALL CITY/PROVINCIAL TREASURERS NATIONWIDE.

WHEREAS, pursuant to Memorandum Order No. 38 and the COA Letter-Opinion dated February 26, 2003, the National Printing Office (NPO) still has the exclusive printing jurisdiction over all standard and accountable forms including those forms specifically designed for the agencies requirements as mandated by Executives Order No. 285;

WHEREAS, to expedite the processing of requests for printing and in order to guide the Technical Committee, the COMBAF and Accredited Security Printers on what jobs can be subcontracted and what jobs should be printed exclusively by NPO;


WHEREAS, all government accountable forms printed by the NPO use watermarked phantom-marked security papers which as stated in the COA-Letter Opinion "this Commission believes and so holds that the present official receipt printed by NPO and being used by almost if not all government agencies in the national, local."
