RESOLUTION NO. SP-**2333**S-2003

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR. TO GRANT FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE CARLOS ROQUE, FORMER PINONG BARANGAY OF BARANGAY CELIAL, QUEZON CITY WHO DIED ON SEPTEMBER 27, 2003, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40, 000.00), TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2004 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, his untimely demise caused great financial difficulty and bleak future to the bereaved family;


WHEREAS, as a manifestation of support and recognition for his untiring commitment to and unselfish public service, it is fitting to grant a financial assistance for his bereaved family
